#### Members must:

Pay housing charges regularly on the first day of every month.

Keep the unit in good shape and report any damages or maintenance required.

Provide financial information for income verification to access government subsidies.

Attend all annual, special and cluster meetings.

Pay a deposit of market rate upon occupancy of unit (payment may be spread over the first 10 months with a minimum payment of \$50 per month). This amount is refundable when a member leaves, less any damages costs.

Give 70 days (or more) written notice of terminating occupancy.

Devote at least two (2) hours a month to the Co-op in the form of committee work, maintenance, or other tasks as determined.

Reside in the unit. The unit can only be occupied by those named on the housing agreement.

Not sub-let the unit. Sub-letting is prohibited.

Dalhousie Co-op does not provide a fridge or stove in any units.

In submitting this application for housing in Dalhousie Non-profit Housing Co-operative, I understand and accept the general co-operative principles:

I authorize Dalhousie Co-operative to undertake a landlord and credit check and verify all information given in this application and I authorize any person, corporation or social agency having the information, to release it to Dalhousie Co-operative.

I understand that, if the co-op accepts us for membership and offers us a unit, we must pay a one-time membership fee of \$10 for each member. I understand that I will sign a Housing Agreement before moving into my unit, and that on move-in day or earlier, I will pay by certified cheque, cash, or money order the amount of market rate to cover the Member Loan, or I will formally agree to pay this amount in no more than ten (10) monthly installments.
